MINUTES OF THE QUARTER ALLOTMENT MEETING HELD ON 22/3/2018 IN THE

Director welcomed all members and informed members that Dr. Arun Banik, Reader is not available, therefore, Dr. Raju Arakh has been nominated as representative of SC/ST.


It was decided that Dr. Raju Arakh, Lecturer will not be part of the Committee when his case will be decided.

Applications for the allotment of quarter have been invited from the staff vide circular No. Estt/2017/5627 dated 18/1/2018 and 24 Nos. of applications were received. The statement has been prepared and the same was uploaded in the website and seven comments have been received from the officials for rectifications. The same have been made and put up before committee for allotment of quarters.

In respect of 60 point roster, it has been brought to the notice of the Committee Member that total 54 quarters (except Guest House) are available and out of that 13 are occupied by staff belonging SC and none by ST. No roster was maintained by the office. Director/Chairman of the Committee directed Establishment Section to start maintaining the roster henceforth from the present occupancy.
