Information sought and background of the case:

The Appellant filed an RTI application dated 23.06.2022 seeking information on the following points:-

1. Provide the copy of C-level ISL Interpreter certificate of the Course Coordinator of DISLI at AYJNISHD (D), Mumbai.
2. Provide the experience details in providing ISL interpretation of DISLI Course Coordinator at AYINISHD (D), Mumbai.
3. Provide the details of Experience of DISLI Coordinator in providing training in Indian Sign Language."

On non-receipt of response from the CPIO the appellant/complainant filed a First Appeal dated 05.08.2022 which was not adjudicated by FAA.

Aggrieved and dissatisfied, the Appellant approached the Commission with the instant Second Appeal.

Facts emerging in Course of Hearing:

Hearing was scheduled after giving prior notice to both the parties.

Appellant: Not present

Respondent: Dr. Gayatri Ahuja- CPIO and Dr. Rajiv Jalvi were present during the hearing through video conference.

A written submission dated 01.01.2024 has been received from the Respondent stating as under:

1. Regarding the copy of the C-Level ISL Interpreter certificate for the course coordinator of DISLI at AYJNISHD (D) Mumbai: **Not applicable**, as the current DISLI Coordinator is a permanent faculty member in the Department of Education and does not possess qualifications related to ISL. The RCI has discontinued Level A, B, and C courses of ISL and only DISLI is currently available which is two years full time course. Ali Yavar Jung National Institute for the Speech and Hearing Disabilities (Divyangajan) is an apex institution working under the Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment, Govt. of India, for the re/habilitation of the individuals with hearing impairment. Course coordinators at AYJNISHD (D) are appointed by the competent authority, i.e., the Director, and only permanent employees are appointed as course coordinators irrespective of the core qualification required as a course coordinator. Further, it is the discretion of the Director to appoint course coordinator for particular course to filter out the basic requirement for appointment of course co-ordinator.
2. Concerning the experience details in providing ISL interpretation for the DISLI course coordinator at AYJNISHD (D) Mumbai: **Similar to point 1.**
3. Details of the experience of the DISLI coordinator in providing training in Indian Sign Language: **Similar to point 1.**

The Appellant has sent a communication dated 01.01.2024 stating as under:

Dear Sir,

I am writing in reference to the file number CIC/AYJNH/A/2022/157422 dated 12-12-2023 against AYJNISHD. I wish to inform you that I am officially withdrawing my complaint and hereby declare that I will not be able to attend the scheduled hearing on 02-01-2023. After re evaluation, I have no remaining concerns or issues with AYJNISHD Mumbai.

Decision:

The Respondent is directed to send a copy of the written submission dated 01.01.2024, mentioned hereinabove, to the Appellant within seven days of receipt of this order. In view of the Appellant's request sent vide communication dated 01.01.2024, the appeal is dismissed as withdrawn.

RTI application filed on : 19/08/2019

Information sought:

The Appellant filed an RTI application dated 19.08.2019 seeking the following information;

1. *"Is it a fact that Shri B.N. Rao at present being I/C Asstt. Director of Kolkata Regional Centre became eligible for employment at your organization purely on reservation basis?"*
2. *If your answer to query No. A is yes, on what category of reservation he was selected.*
3. *Whether proper verification/authentication of Mr. B.N. Rao's documents/credentials in respect of eligibility criteria for reservation educational certificates and birth certificate issued by Registrar of Birth and Death was duly undertaken."*

The CPIO replied to the Appellant on 11.11.2019 stating that information sought cannot be provided as per section 8(g) of the RTI Act, 2005.

Being dissatisfied, the Appellant filed a First Appeal dated 27.11.2019. FAA's order dated 18.12.2019 upheld the reply of CPIO.

Feeling aggrieved and dissatisfied, Appellant approached the Commission with the instant Second Appeal on the ground of non-receipt of desired information from the CPIO.

Relevant Facts emerging during Hearing:

The following were present:-

Appellant: Present through audio-conference.

Respondent: Dr. Gayatri Ahuja, Faculty (Department of Education) & CPIO along with Dr. Rajiv Jalvi present through audio-conference.

The CPIO relied on her written submission dated 13.08.2021 and submitted that the Appellant has sought information regarding the employment of the concerned person on reservation basis which pertains to personal information of a third party, therefore, the same has been denied to him now under Section 8(1)(j) of RTI Act. She further tendered her unconditional regret for wrong quoting of Section 8(g) by the then CPIO while denying the information which was later rectified through the averred written submission.

The Appellant stated that no information has been provided to him by the CPIO till date.

Decision:

The Commission based upon a perusal of facts on records observes that the information sought for by the Appellant is rather about seeking clarifications/inferences from the CPIO based on his speculative queries which do not strictly conform to Section 2(f) of RTI Act.

Notwithstanding the aforesaid, also the CPIO has appropriately denied the information relating to reservation basis employment details of concerned person being third party, to the Appellant under Section 8(1)(j) of RTI Act. In this regard, the attention of the Appellant is drawn towards a judgment of the Hon'ble Supreme Court in the matter of **Central Public Information Officer, Supreme Court of India Vs. Subhash Chandra Agarwal in Civil Appeal No. 10044 of 2010 with Civil Appeal No. 10045 of 2010 and Civil Appeal No. 2683 of 2010** wherein the import of "personal information" envisaged under Section 8(1)(j) of RTI Act has been exemplified in the context of earlier ratios laid down by the same Court in the matter(s) of **Canara Bank Vs. C.S. Shyam in Civil Appeal No.22 of 2009; GirishRamchandra Deshpande vs. Central Information Commissioner &Ors., (2013) 1 SCC 212 and R.K. Jain vs. Union of India &Anr., (2013) 14 SCC 794**. The following was thus held:

"59. Reading of the aforesaid judicial precedents, in our opinion, would indicate that personal records, including name, address, physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as personal information. Similarly, professional records, including qualification, performance, evaluation reports, ACRs, disciplinary proceedings, etc. are all personal information. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded, including that of the family members, information relating to assets, liabilities, income tax returns, details of investments, lending and borrowing, etc. are personal information. Such personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interest is satisfied. This list is indicative and not exhaustive..."

In view of the foregoing, the Commission finds no scope of further intervention in the matter and upholds the CPIO's submission.

The appeal is disposed of accordingly.

In light of the above, following is the submission;

- The Appellant vide application dated 19-08-2021 had asked about the employment of the public servant on the basis of reservation. The said information was not provided because it was personal. Further, as per Section 8(1) (j) of the RTI Act, 2005 as the said information which related to personal information the disclosure of which has no relationship to any public activity or interest hence was not provided.
- The Supreme Court has ruled out that service details of an employee can't be shared with an RTI applicant as 'personal information' is exempt from disclosure under the Right to Information Act, unless there was larger public interest involved and the RTI applicant has not justified that this information is sought for public interest. The Appellant had asked about personal credentials of Public Servant, hence it was denied under Section 8 (1)(j).
- With regard to the third party, third party has denied to give his personal information.

However if CIC directed we will provide necessary information as per appellant
