a) Details of number and percentage of deaf persons in the country

In India, over 100000 babies are born with hearing impairment every year. It is an invisible impairment/disability; hence it is not detected easily. Census of India (2011) has provided details about children and adults from various age groups affected with hearing loss. According to Census of India (2011), there are 476075 children with hearing loss in the age group of 0 to 6 years (Excel sheet attached).

b) Details of the support provided to deaf persons, including the funds provided to support states, particularly Andhra Pradesh

The scheme of Assistance to Disabled Persons for purchase/fitting of aids/appliances (ADIP SCHEME) has been in operation since 1981 with the main objective to assist the needy disabled persons in procuring durable, sophisticated and scientifically manufactured, modern, standard aids and appliances to promote physical, social, psychological rehabilitation of Persons with Disabilities by reducing the effects of disabilities and at the same time enhance their economic potential. Assistive devices like hearing aids are given to persons with hearing impairment (PwDs) with an aim to improve their independent functioning, and to arrest the extent of disability and occurrence of secondary disability. (Details of aids and appliances provided below:

There are other schemes to support deaf persons in other aspects such as vocational habilitation, job placement, etc.

c) Whether the Government provides free cochlear implants to deaf persons under any scheme

In the light of the Government's commitment for enabling and empowering disabled persons, it was decided in 2014 to continue and modify the already-existing ADIP Scheme in such a way that it becomes more user-friendly and the needy are not deprived of necessary aids /appliances for want of means to acquire them together with a transparent mechanism for checks and balances. During the revision of the ADIP scheme in 2014, it was decided to include cochlear implant for children with hearing impairment. The objective of inclusion of cochlear implantation under ADIP scheme is to provide cochlear implantation to children and support for auditory verbal habilitation to operated children through empaneled rehabilitation centers. Implementing agency for cochlear implantation under Revised ADIP Scheme (2014) is Ali Yavar Jung National Institute for Speech and Hearing Disabilities (Divyangjan).
